“Dynamic Techniques for Use in the Play Room”

This workshop is designed to provide clinicians with knowledge and skills that will enhance their ability to treat children. They will learn techniques to use in the playroom and understand each technique's developmental value. Instruction will include examples of individualized techniques, games, bibliotherapies and basic sand tray use. Participants will have hands on experience with some of the techniques and then share their experiences. Participants will also be encouraged to share techniques that they currently use and are helpful in their practice. Sample phrases will be offered as to how to translate what we do as play therapists into user-friendly terms for insurance and managed care.

Teri V. Krull, LCSW, LLC – Teri Krull is one of the founders of AzAPT. She served as its President in 1994 and served as APT's Arizona membership representative for 10 years. She served on the national board of APT from 1996 to 2003 and was their President in 2000. She has been a play therapist in private practice for 22 years and has taught Child Play Therapy classes at Arizona State University. She is currently the Director of the Center of Positive Regard located in Chandler, Arizona.
